Each year the intent of the ATCLUFN meeting is to provide First Nations with a unique opportunity to network with other colleagues, to share concerns & knowledge and to discuss current technical issues that face their Communities. Therefore, in order to provide our delegates with the most comprehensive and useful information we are suggesting that each First Nation select the most suitable candidate that will best represent your technical issues and concerns.

OFNTSC will sponsor the following participants to attend the ATCLUFN meeting:

- Travel and accommodations will be reimbursed for all OFNTSC Board of Directors;
- Travel and accommodations will be reimbursed for (1) representative from each Tribal Council in Ontario;
- Travel and accommodations will be reimbursed for (1) representative from each Large First Nation in Ontario;
- Accommodations will be reimbursed for (2) representatives from each Unaffiliated First Nation in Ontario and only (1) travel will be reimbursed.

Sponsored delegates will have their accommodations billed directly to the OFNTSC master account and any eligible expense incurred will must be submitted by a travel expense claim form which will be provided at the ATCLUFN meeting.
